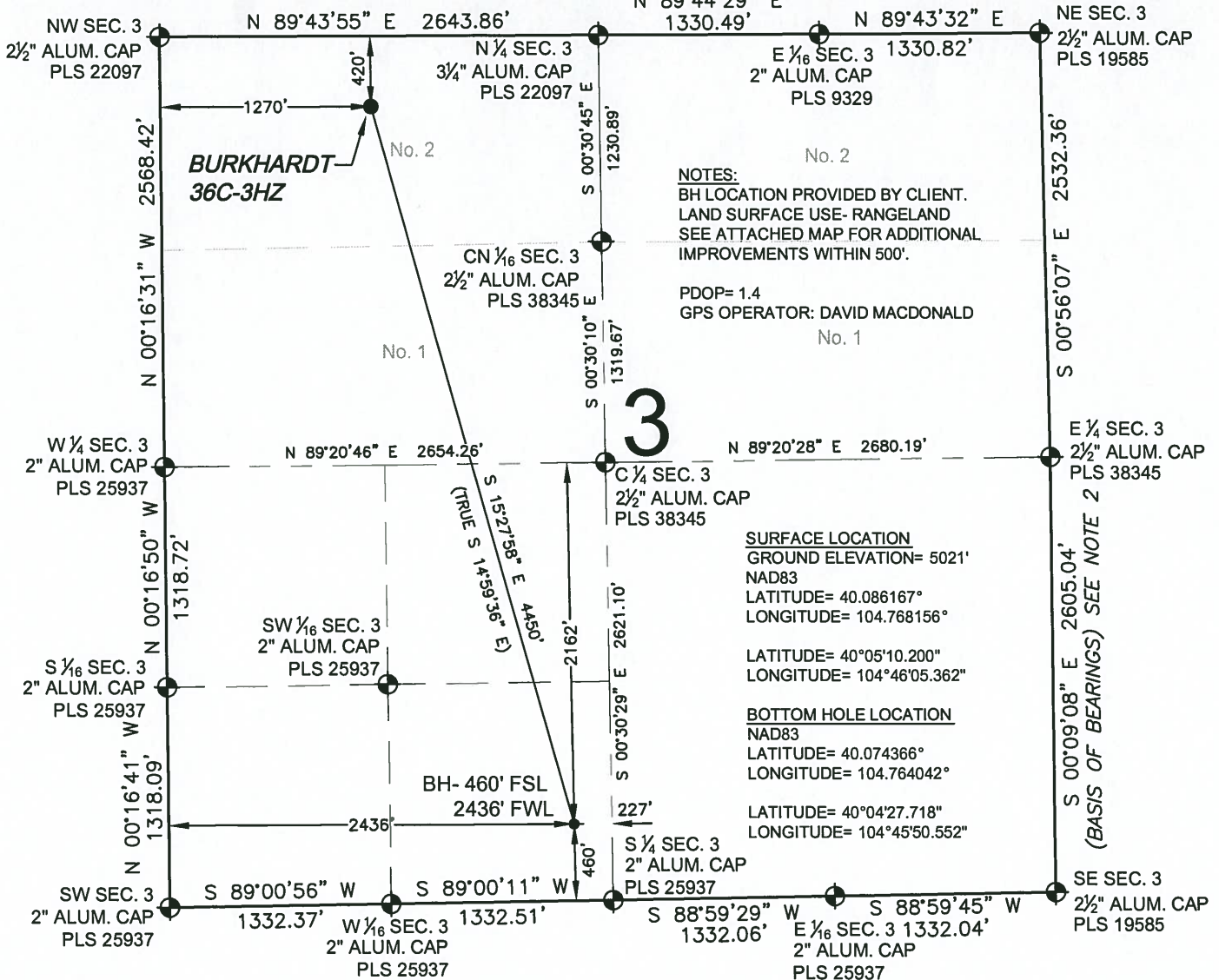


# WELL LOCATION CERTIFICATE: BURKHARDT 36C-3HZ

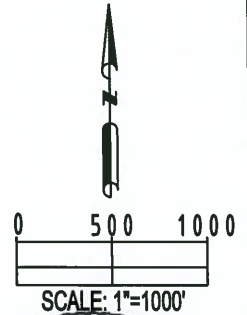
