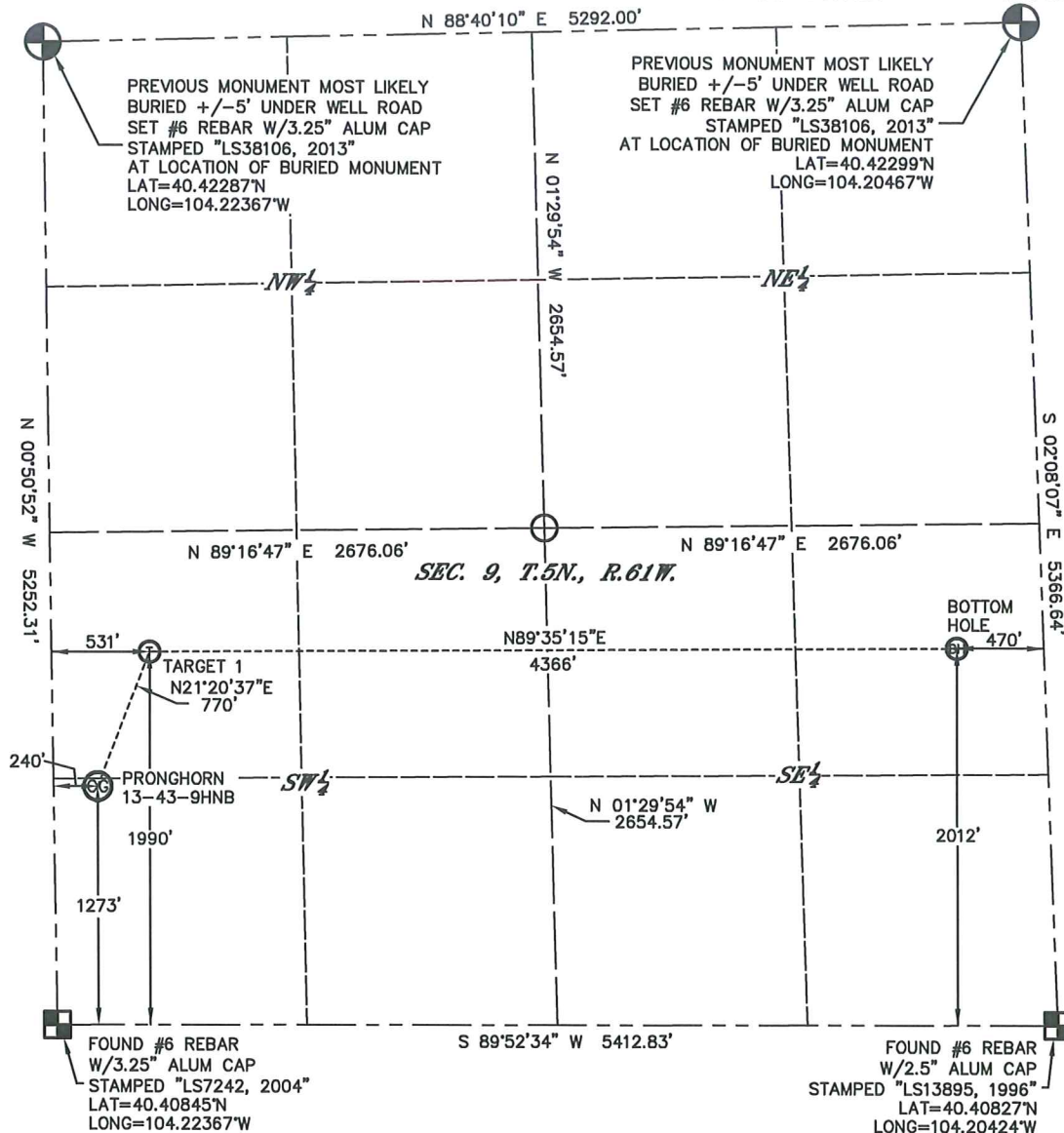


WELL LOCATION CERTIFICATE

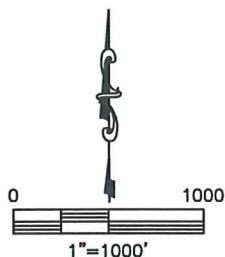

In accordance with a request from RANDY EDELEN with BONANZA CREEK ENERGY, INC., King Surveyors has determined the surface location of PRONGHORN 13-43-9HNB to be 1273' from the SOUTH line and 240' from the WEST line and the bottom hole to be 2012' from the SOUTH line and 470' from the EAST line, as measured at right angles, from the section lines of Section 9, Township 5 North, Range 61 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 12-09-2013, for and on behalf of BONANZA CREEK ENERGY, INC., that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
