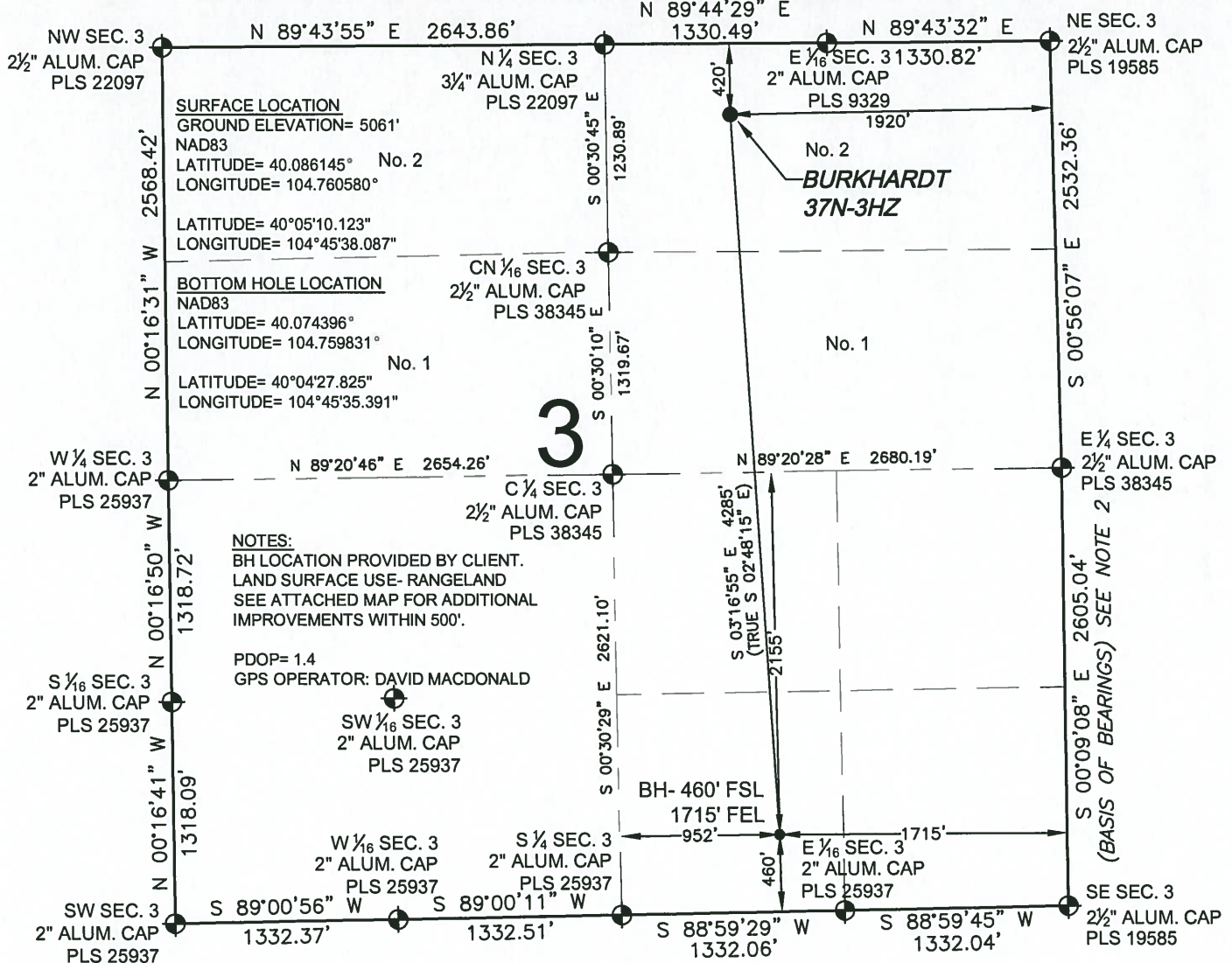


WELL LOCATION CERTIFICATE: BURKHARDT 37N-3HZ

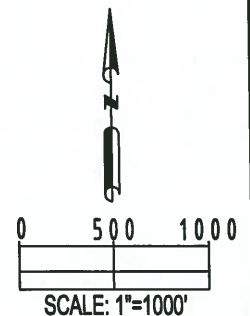
