## OPERATOR COMMENTS AND SUBMITTAL

Comments While drilling the curve of Wells Ranch AA21-68-1HC (API #: 05-123-37701) a motor failure occurred which led to us losing inclination from 48.5 degrees to 36.6 degrees. With this being a Codell well, the decision was made to plug back and re drill the curve because there was no way we would be able to land our curve and set 7" casing near the Codell at the planned inclination. Could have ended up well below the target formation in the Carlile or in the Greenhorn formation and would have been in no position to try and drill back up into the Codell with our lateral drilling assembly. MD of proposed KOP = 6030'. Proposed objective formation(s) and BHL target of sidetrack well will remain the same. Verbal approval to sidetrack was received by Noble via the phone from Diana Burn of the COGCC on 02/25/14.
