This well was listed as part of a COA for the Noble Marie D04 72,73-HN. It was originally determined this well would require additional cement of the Fox Hills Aquifer. During operations, a CBL showed some possible spots of coverage. The State requested a log from 1500' to surface. CBL logged from 3600' to surface. Logs showed some spots of possible cement bond and top at 2930'. State Engineer(Mike Hickey) determined we had enough cement coverage above the parkman/sussex. Attached is the CBL.
