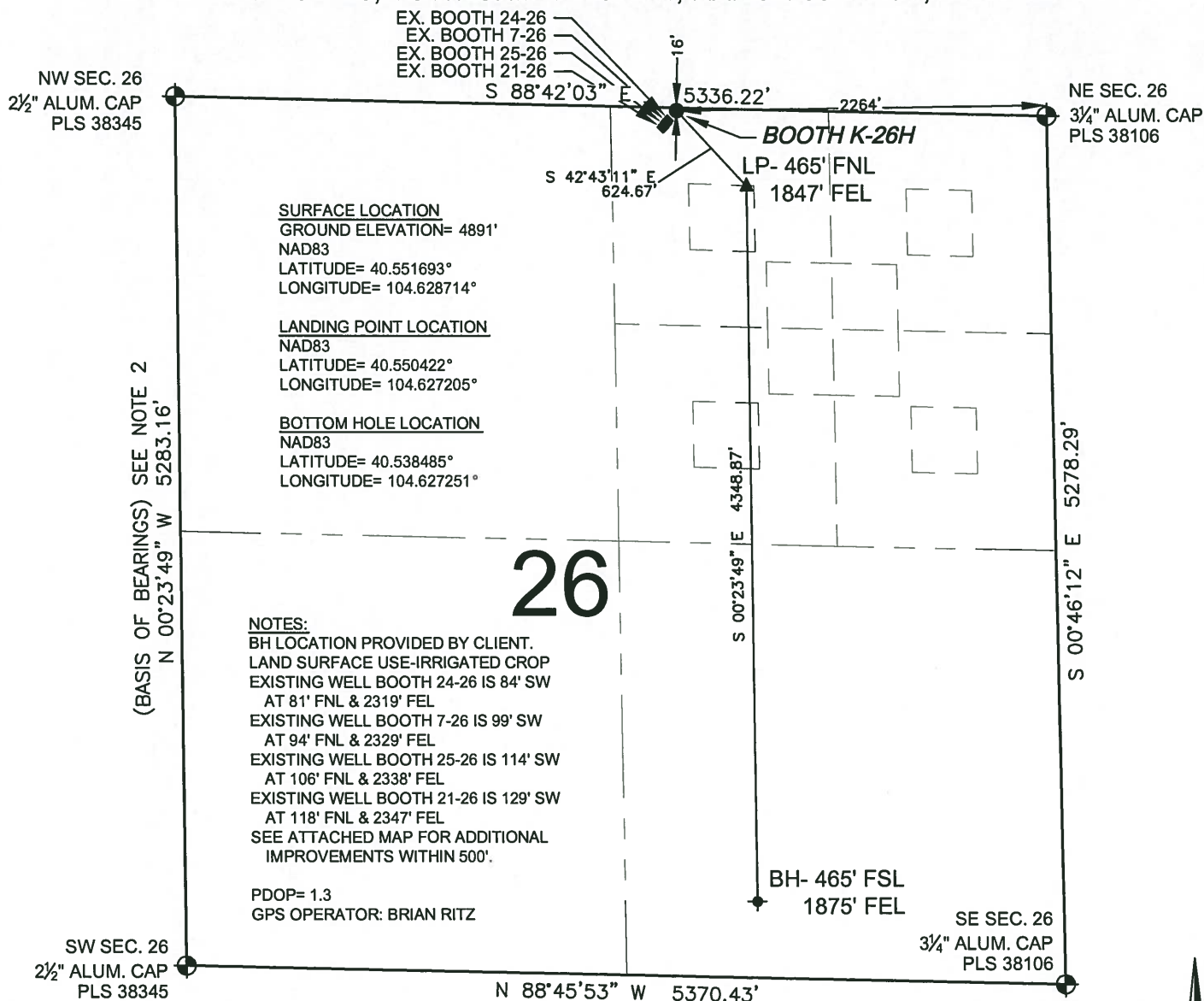


WELL LOCATION CERTIFICATE: BOOTH K-26H

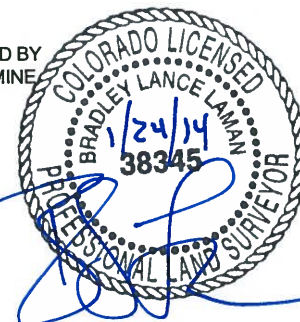
