COMMENTS:

CoP/Burlington is notifying the intent to flare/Combust gas at this location using an enclosed combustor. The nearest pipeline is located approximately 58,080 feet from location and construction of the pipeline tie in will not be completed till approximately 8-1-2014. The daily mcf that would be flared/ combusted would be approximately 730 mcf/day for a total of 266,450 mcf/yr. The analytical attached shows that H2S concentration in the gas is 6.5 ppm.
