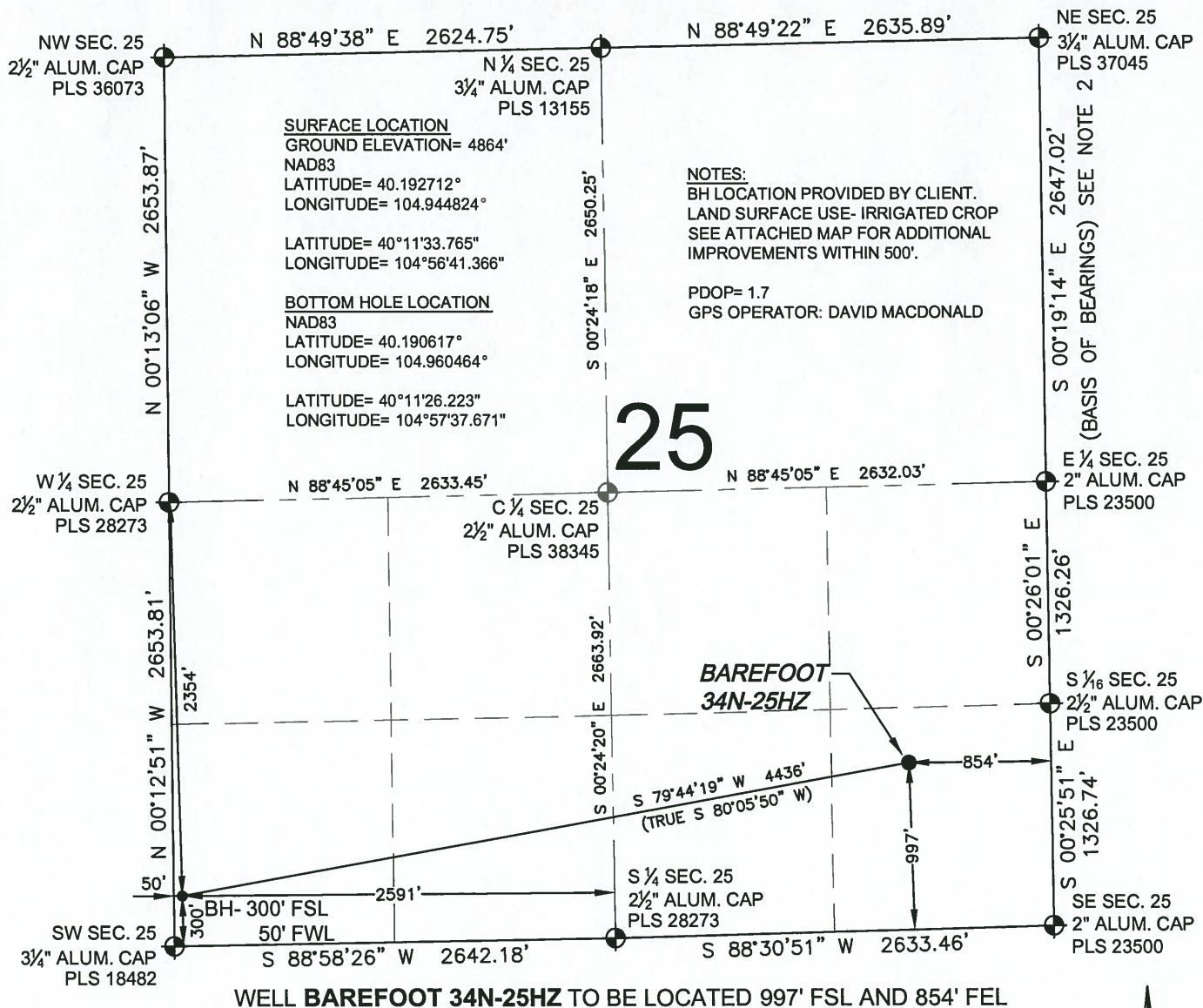


WELL LOCATION CERTIFICATE: BAREFOOT 34N-25HZ

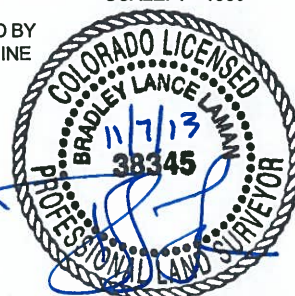
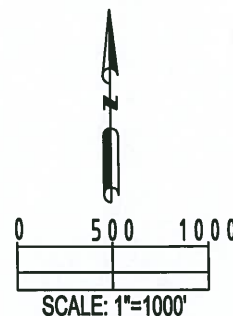
