Mr. Anderson,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have the following comments.

- 1) Per COGCC Rule 303.b.(3)C, please provide me a description of all oil, gas, and/or water pipelines that will be on this location. This should include any lines from the wellhead to the separators to the tanks etc. Your description should include at a minimum whether the lines are buried or not, how many, their size, and material. For example: "One 3-inch coated steel buried flowline from the wellhead to the separator."
- 2) In the Construction section you have indicated the date planned to commence construction is 2/11/14. Since this Form 2A has not been approved, this date must be sometime in the future. Please provide me with an updated date planned to commence construction.
- 3) In the Drilling Waste Management Program section you have indicated that drilling fluids disposal method will be via Land Application, but you have also indicated that a Land Application Plan has not been submitted to the COGCC. Land Application Plans must meet COGCC Rule 907.d.(3) requirements and be submitted for our review prior to disposing of drilling wastes. Please submit your Land Application Plan to the COGCC via a Form 4 Sundry Notice or revise your drilling fluids disposal method and I will change it on the Form 2A.

Hello Doug.

Here are answers to number 1-3.

Item 1

1, 3" Fiberglass flow-line would be buried 48" deep from wellhead to separator. A 1" Poly return gas line would be buried 48" deep to provide gas back to a pumping unit should one be utilized. Interconnecting battery equipment piping and fittings (separator to crude and water tank(s), gas metering equipment if applicable, valves etc) would be sized as required to accommodate their intended purposes, and be comprised of industry standard materials. Interconnecting piping would also be buried to provide a hazard/obstacle free worker environment.

Item 2

Construction is anticipated to commence March 17, 2014

Item 3

I am working with the surface owner for written approval for land disposal of water based drilling fluids. Once I have that, I will contact John Noto of COGCC per your recommendation and work with him on an acceptable Land Application Plan for submittal.

Please let me know if Items 1 & 2 fulfill your needs as I work on Item 3.
