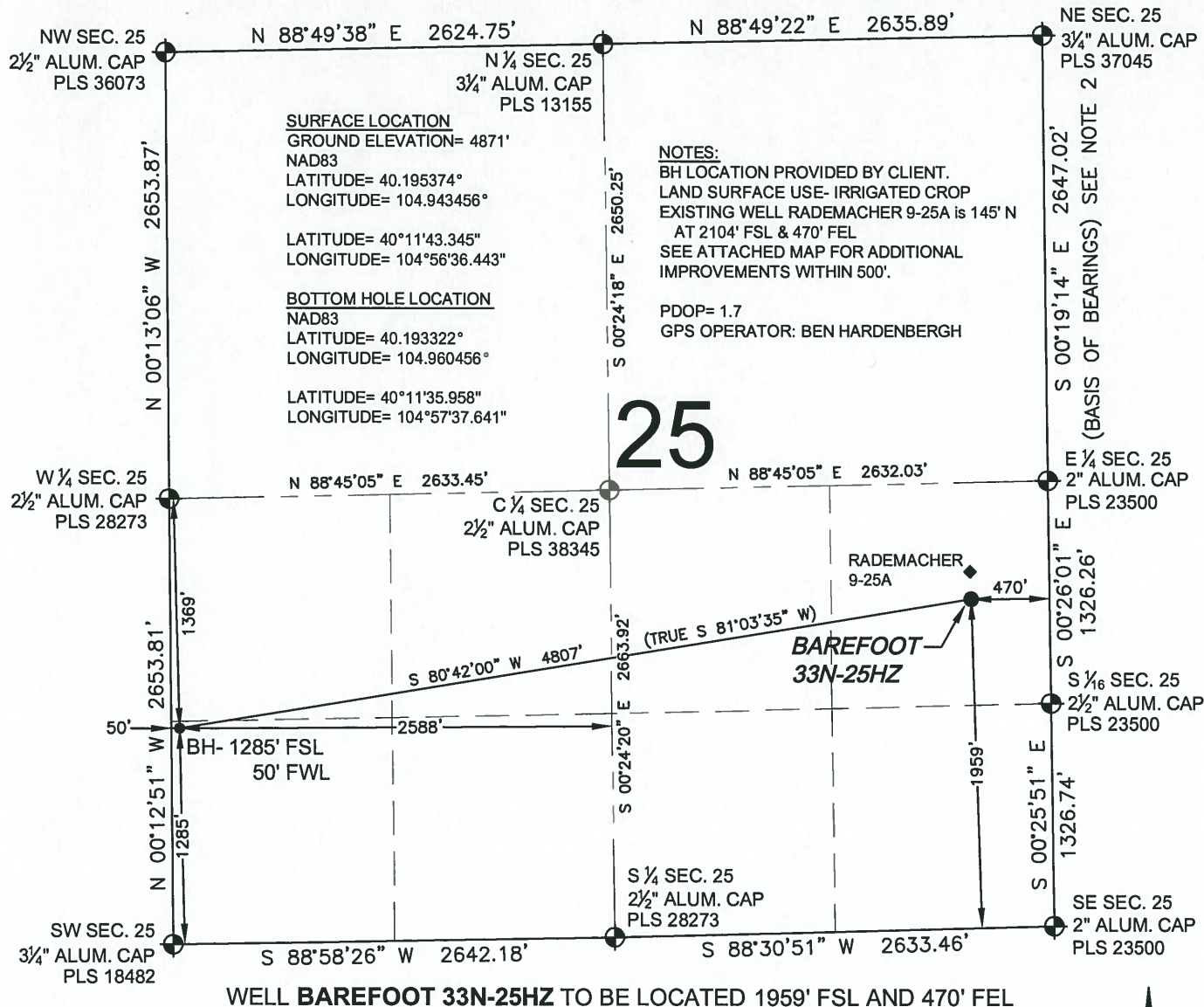


WELL LOCATION CERTIFICATE: BAREFOOT 33N-25HZ

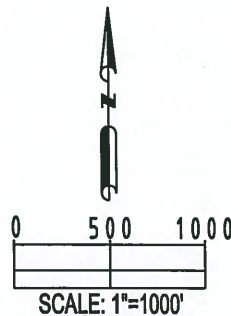
