This pad is located in the SE/4SE/4 of Section 11, Township 6 South, Range 92 West of the 6th P.M. and is approximately 0.75 mile Southeast of the Town of Silt off of County Road 311. 
Ursa Operating Company LLC (Ursa) is committed to our community and being positive environmental stewards.

FROM I-70 SILT EXIT 97 PROCEED SOUTHERLY ALONG HIGHWAY OVERPASS 0.1 MILES TO THE FRONTAGE ROAD. TURN LEFT AND PROCEED EAST ALONG FRONTAGE ROAD 0.42 MILES TO CO. RD. 311. TURN RIGHT AND PROCEED SOUTH ALONG CO. RD. 311 FOR 0.57 MILES. CO. RD. 311 WILL VEER LEFT IN AN EASTERLY DIRECTION, CONTINUE ON CO. RD. 311 FOR 0.4 MILES. TURN RIGHT ONTO VALLEY FARMS ACCESS ROAD AND PROCEED SOUTH FOR 0.3 MILES. TURN LEFT ONTO VALLEY FARMS L PAD ACCESS ROAD FOR 0.3 MILES TO THE VALLEY FARMS L PAD SITE.
