COMMENTS:

WPX pumped two cement jobs. The first job went as planned until WPX tried to drill out and the cement on top of the retainer was not hard yet. WPX let it sit another day and then tried again, and had the same thing. WPX then drilled it all up and pumped a new job across those perms. Attached find both PJR's for these jobs.

WPX pumped 200 sacks of squeezecem™ at 13.5 ppg, 1.54 ft^3/sack. Then then pumped 30 sacks of squeezecem™ at 12.7 ppg, .86 ft^3/sack as a balanced plug on top of our retainer set at 6900'. We will be drilling out this morning (March 3rd) and pressure testing.
