#### COMMENTS:

This is a update for work performed on the SG 433-27: POOH with 2 3/8" tubing. Pick up retrievable bridge plug (RBP) and RIH and set at 1780'. Pressure test plug to 1000 psi. Spot 2 buckets of sand on top of plug. POOH with tubing. MIRU wireline. Perforate 3 squeeze holes at 1650'. POOH and RD wireline. Pump injection test. MIRU cement crew. Pump 100 sacks 16 ppg (1.14 cuft/sk yield) cement. Displace with 24 bbls bbls. Shut in casing with 1775 psi. Shut in bradenhead. RD cement crew. WOC. Bradenhead pressure 5 psi. PU bit and casing scraper and RIH. Tag at 1450'. Drill out cement to 1769' and circulate hole clean. MIRU wireline and run CBL. New TOC 1630'. Pressure test squeeze holes to 1000 psi. PU retrieving tool and RIH to pull RBP at 1780'. POOH with RBP and break out tools. Pick up BHA and tubing and RIH. Land tubing at 5047', 160 joints 2 3/8" tubing. Turn well back over to production.
