- 1 MIRU service rig
- 2 POOH 2-3/8" tubing
- 3 Run gauge ring, set RBP at 2600', perforate squeeze holes @ 2530', pump injection test
- 4 RU cement crew and pump 100 sks of 15.8 ppg cement
- 5 Shut in well and wait on cement
- 6 Drill out cement and pressure test to 1000 psi
- 7 Monitor bradenhead pressure for compliance
- 8 Return to production or continue squeezing until compliant
- 9 Submit post bradenhead squeeze Sundry
