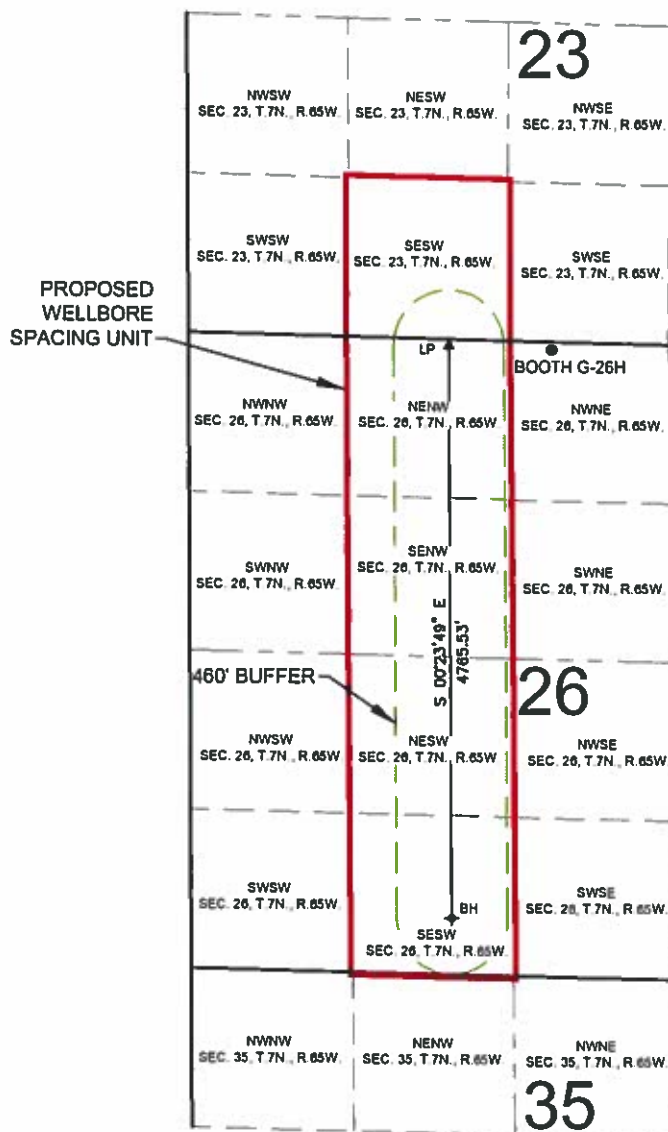

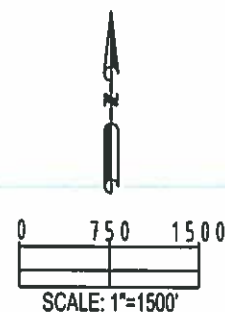
LANDING POINT LOCATION
