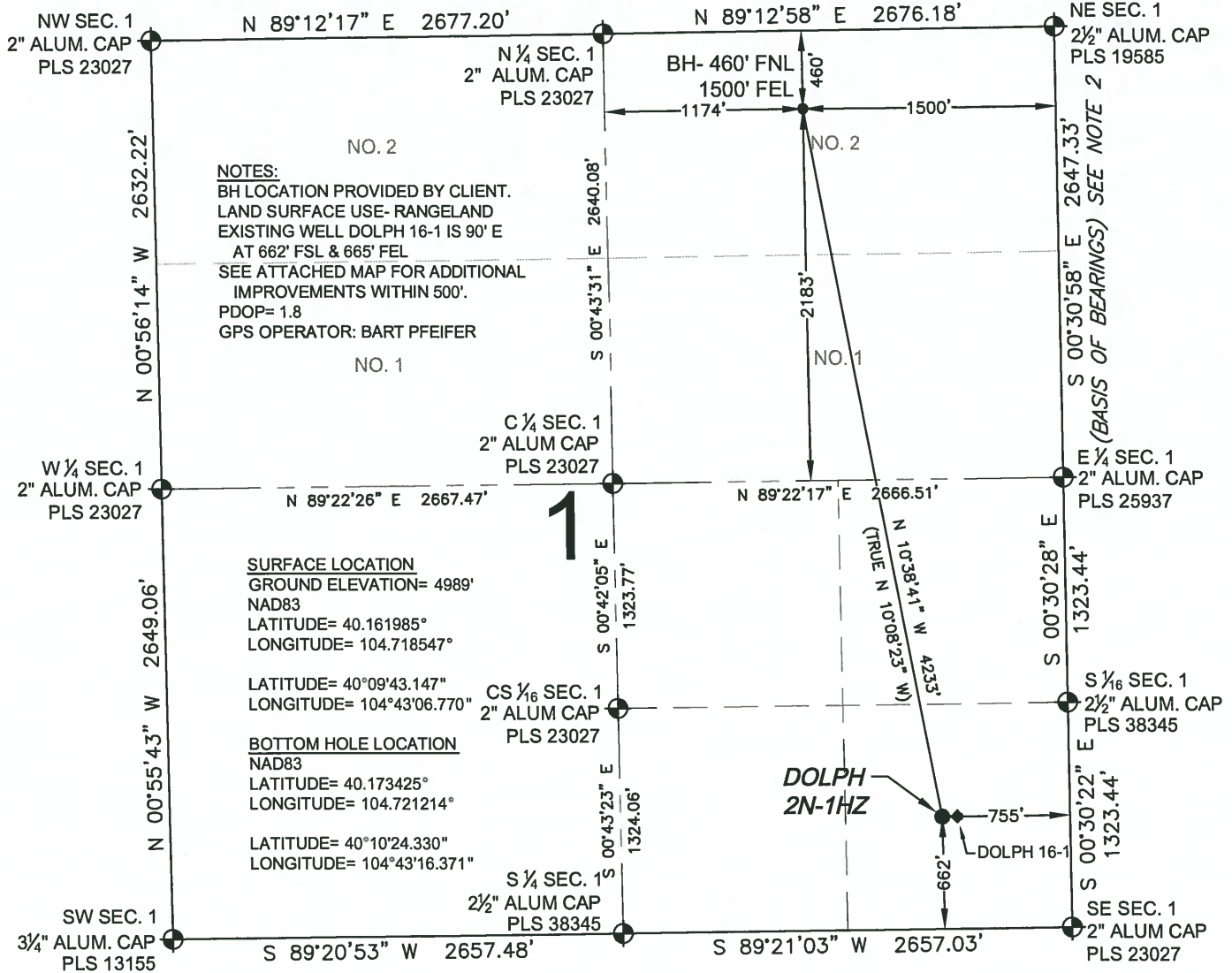


WELL LOCATION CERTIFICATE: DOLPH 2N-1HZ

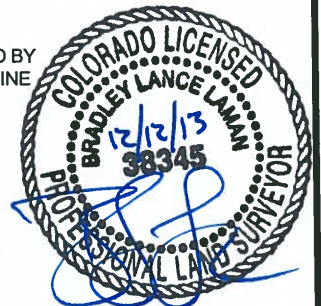
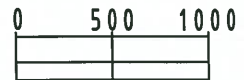
