Dear Steve:

Bill Barrett Corporation ("BBC") is contemplating the drilling of four wells from a location in the Northeast Quarter of the Northwest Quarter (NENW) of Section 15-4N-62W, 6th P.M., Weld County, Colorado on lands owned by Equus Farms, Inc. This location will be outside of the Greater Wattenberg Area 400' Window which requires BBC to obtain the waiver of Equus Farms, Inc. to the provisions of Rule 318A.a.

Additionally, the location to be proposed is more than 2000' from the nearest existing well which requires BBC to also obtain the consent of Equus Farms, Inc. to the location exception under Rule 318A.c. Surface Locations. This Rule requires the consent of the land owner for any wells that will be located more than "...50 feet from a well..." in order to receive administrative approval of the location.

The above waiver and consent are allowed pursuant to Rule 318.c. Exception Locations. Accordingly, I have attached what is referred to as a window and twinning waiver and request that you obtain the execution of Equus Farms, Inc. so that we may proceed with our permitting processes for 2014.

(a) of the Colorado Oil and Gas Conservation Commission's Rules and Regulations that provides that wells shall be drilled within a square with sides four hundred feet (400') in length, the center of which is the center of any governmental quarter-quarter section, ("400' Window"). Equus Farms Inc. hereby consents and authorizes Bill Barrett Corporation to drill, complete and operate the following wells from the surface hole locations indicated:
