COMMENTS:

This COGCC Form 4 is being submitted as a request to meet the background concentration levels for arsenic at the RGU 41-1-298 pad in accordance with footnote 1 to the COGCC table 910-1. The request is based on the analytical results presented below (see attached laboratory report). One composite sample was collected from three separate locations within the trench to determine the arsenic concentration in the cuttings. RGU 41-1-298 (cuttings) - 5.7 mg/kg. Five grab samples were collected from nearby non-impacted, native soil to establish the background arsenic concentrations. RGU 41-1-298-B-1 - 5.0 mg/kg; RGU 41-1-298-B-2 - 5.4 mg/kg; RGU 41-1-298-B-3 - 5.2 mg/kg; RGU 41-1-298-B-4 - 5.0 mg/kg; RGU 41-1-298-B-5 - 4.5 mg/kg. WPX Energy is requesting this approval in order to proceed with closure and reclamation of the cuttings trench located on the RGU 41-1-298 well pad.
