This COGCC Form 4 is being submitted as a request to meet the background concentration levels for arsenic at the RG 24-14-298 pad in accordance with footnote 1 to the COGCC table 910-1.

The request is based on the analytical results presented below (see attached laboratory report).

One composite sample was collected from three separate locations within the cuttings trench to determine the arsenic concentration in the cuttings.

RG 24-14-298 (cuttings) - 8.2 mg/kg

Five grab samples were collected from nearby non-impacted, native soil to establish the background arsenic concentrations.

RG 24-14-298 -B-1 – 7.7 mg/kg

RG 24-14-298 -B-2 – 4.5 mg/kg

RG 24-14-298 -B-3 – 5.3 mg/kg

RG 24-14-298 -B-4 – 5.4 mg/kg

RG 24-14-298 -B-5 – 4.3 mg/kg
