Attachments required with a Subsequent Report are a wellbore diagram showing plugs that were set and casing remaining in the hole, the job summaries from all plugging contractors used, including wireline and cementing (third party verification) and any logs that may have been run during abandonment.

Contacted Dirk Sutphin on 1/6/2014 with the following explanation, We have had a rig on this well for five days going on six today, and from all indications the hole has collapsed and we have sidetracked. We have reached a depth of 845', drilling hard sand and shale. Our plan now is to set a cement plug from 845' to surface, in two stages, which will isolate all fresh water zones. Dirk approved the operation on 1/6/2014 by email.

Carrizo re-entered and plugged the McArthur #1 due to an offset well evaluation of our Bailey 5-26-8-60 (05-123-37372). This well was within 1500' and required adequate plugging prior to fracing. An as-plugged WBD is attached.
