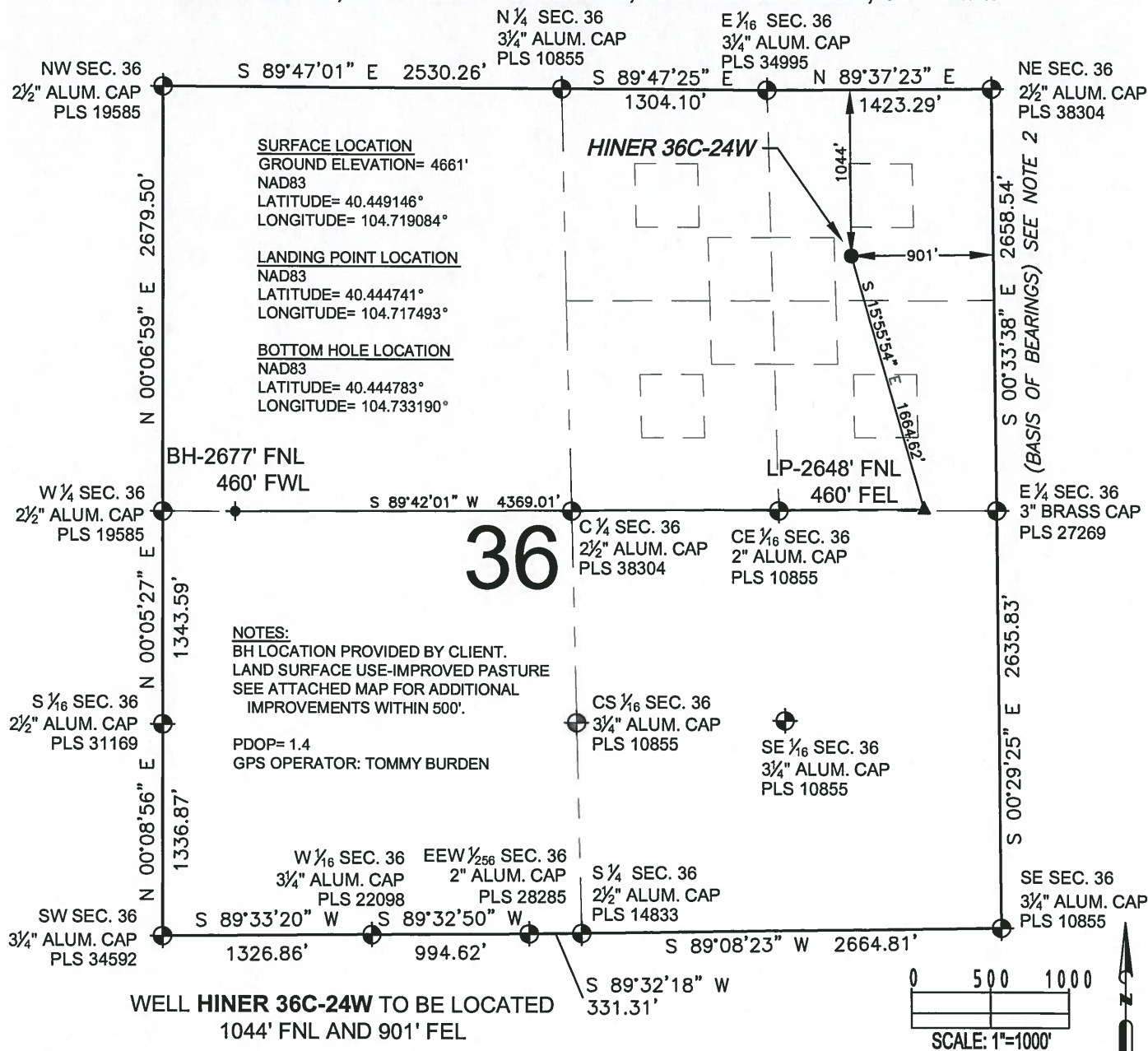


WELL LOCATION CERTIFICATE: HINER 36C-24W

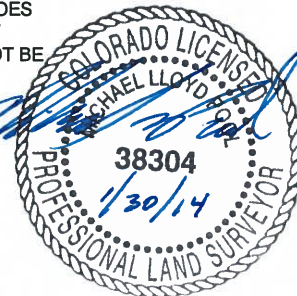
- = EXISTING MONUMENT ▲ = LANDING POINT
