In accordance with the requirements of Rule 305.a.(1) of the Colorado Oil and Gas Conservation Commission (COGCC), this letter serves as Urban Mitigation Area Notice to the Local Government Designee by Extraction Oil & Gas (Extraction) of its intentions to conduct drilling operations on the captioned wells. Extraction, as operator, estimates operations to begin within 90-120 days, pending receipt of required permits, approval of title, and drilling rig availability. Additional notice pursuant to COGCC Rule 305.c. will be sent by Extraction.
