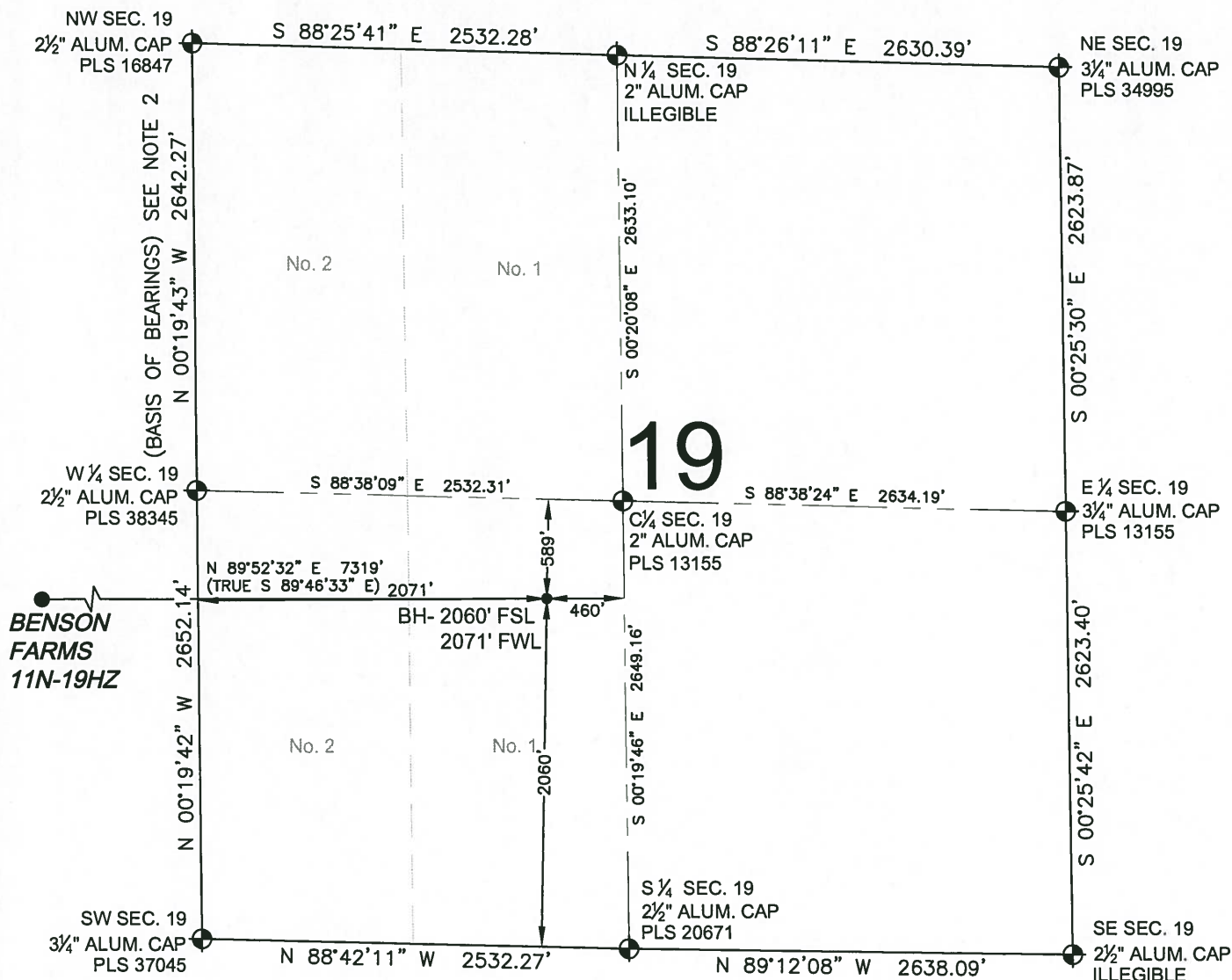


WELL LOCATION CERTIFICATE: BENSON FARMS 11N-19HZ

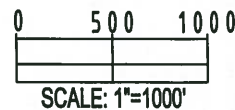
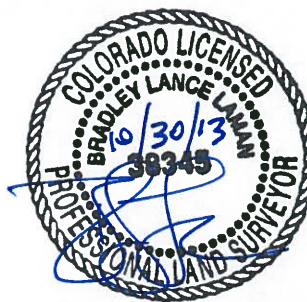

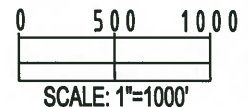
