## COMMENTS:

Due to high production volumes an additional compressor is needed for this facility location. Updated equipment inventory is attached. The compressor will be added, as noted on the Production Facility Location drawing, within the existing disturbance. The original 2A (doc 400186756) approved 8/21/11, identified the surface disturbance to include both the 3-well pad and the production facility though the location drawing depicted the new disturbance. To show the current status of the location two aerial photos are included. Aerial #2 shows disturbance to the east of the pond south of CR 76. That is farming/irrigation equipment. It also shows the buildings listed on the Production Facility Loc Drawing. No noise mitigation will be needed for these buildings. Soil type is 48 - Olney Fine Sandy Loam, 3-5% slope.
