The Operator has been conducting baseline surface water sampling 2x per year since Nov. 2008. Analytical results after 2010 did not include all the sample analytes listed in the COAs of this location (BTEX/TPH - GRO & DRO, and PAH's) as these were always non-detect. The Operator is submitting the Nov. 2010 sampling report and analytical results, which has the full sampling suite listed in the COAs. Sample #001 is on Beaver Creek and is just upgradient of Pad 36A (see attached Map) and is submitted for baseline surface water data per the COAs. The Operator does not have the lab results in EDD format.

Future water sampling will include all sample parameters listed in the COAs of this location.
