**Inspector Comment:**

Crews have removed netting from pits. Netting it to be replaced with new netting prior to returning any wells to production. freeboard has been restored in main pit. a wet spot has been witnessed on this and previous inspections, it is on the west side of pit, near lat/long 40.307551/-107.690354 that area should be visually monitored and analytically sampled to determine if this wet spot is related to the pit or natural, it should be investigated while other sampling activities are taking place. Residual oil was witnessed in the discharge stream below the weir, prior to resuming discharge into stream, all visible hydrocarbon should be removed, it is preferred that this is done with handtools to minimize the disturbance of soil in and around stream.
