Details of work:

Control well w/ 30 bbls kill fluid. RIH w/ 2 7/8" blade bit, and 3 1/2" scraper, 159 jts. Tagged fill at 5000 KB. Roll hole. TIH w/ WLTC RBP, retrieved head, 136 jts. Set RBP @ 4280' KB w/ 136 jts. Roll hole clean. PSI test csg to 500#, with no pressure loss. Dump 1 sk of sand on plug. Unland casing.

RIH w/16 jts of 1 1/4" to 503'. Roll hole clean. Pump 250 sks of "G" neat 15.8 ppg cement from 508' to 10'. Reland casing @ 60000# pack off well head. Bond log from 4000' to surface, cement bond looked good. RIH w/ retrieving head and establish circulation and latch onto RBP. Roll hole clean and release RBP. Rig down and move off.
