#### COMMENTS:

Samson Resources is planning on temporarily abandoning the subject well due to the planned drilling of another well on the same pad, the Southern Ute 32-7-10 #15. The tubing, rods & pump will be pulled from the well, and two CIBPs set with a fluid barrier between the plugs. The deep plug will be set just above the producing interval, with the second plug set shallow. This work is necessary due to the proximity of the existing well to the new drill surface location. This work is estimated to commence around 4/16/2014. The well is expected to be returned to production 2-4 weeks following the temporarily abandonment by drilling out the CIBPs and re-running tubing, pump & rods.
