POH hanger to rig floor; lay down 2 3/8" tubing

RIH with RBP set at 3020'; moved packer up the casing to confirm the leak location

Determined leak in casing between 825' and 887'

Reset RBP to 1019'

Pumped 43 sks of Fine Cement

Displaced cement with 4.5 bbls of fresh water

Slowly pulled out of cement

Reverse circulated the tubing clean

TOH with tubing

Held pressure at 1100 psi and secured the well overnight

Tagged cement at 836'

Pressure tested 250-1500 psi - successful

Drilled out cement from 836' to 921'

Slow drilled cement/sand to top of RBP retrieving neck, circulated clean.

Packer RIH to 3005' per discussion with COGCC 9/26/13 re issue with bridge plug holding at 3325' due to the extreme angle of the wellbore at that depth.

MIT on casing - passed. Ran a second MIT - passed. (Tests attached; originals sent to COGCC)

POH with packer and RBP
