Dear Mr. Chesson:

As per COGCC Rule 318A e (4), baseline water well sample testing is required prior to drilling the first interior infill well or boundary well within a governmental section. COGCC stamped the drilling permit for the wells listed on page 2 requiring Noble Energy, Inc. (Noble) to conduct water sample baseline testing.

Research was conducted to identify and contract water well owners to meet Rule 318A criteria for the above-referenced well. Based on these findings, Noble is requesting a determination of NOT REQUIRED under 318A. e (4) D for the required sampling due to the fact that no wells were found which meet the criteria of Rule 318A Section e (4) A-D.
