Dear Mr. Lepore:

Please let this letter serve as a request for administrative approval of an exception location to Rule 318A.m. The proposed lateral for the Vogl Geist 2C-5H E267 well is planned to be less than 150', as required by Rule 318A.m., from the following existing well:

Merle McHale Ut 2: SWNW Sec. 5 T2N R67W, API # 05-123-14922

The operator of the well listed above is Kerr-McGee Oil & Gas Onshore LP. Kerr-McGee Oil & Gas Onshore LP waives the Rule 318A.m. requirement and grants consent to allow Encana to drill the well with the 150' minimum intra-well distance provided for in said rule by signing the waiver attached.

Prior to drilling operations, Encana Oil & Gas (USA) Inc. will perform an anti-collision scan of existing offset wells that have the potential of being within close proximity of the proposed well. This anti-collision scan will include definitive MWD or gyro surveys of the offset wells with included error of uncertainty per survey instrument, and compared against the proposed well path with its respective error of uncertainty. If current surveys do not exist for the offset wells, Encana Oil & Gas (USA) Inc. may have gyro surveys conducted to verify bottom hole locations. The proposed well will only be drilled if the anti-collision scan results indicate that there is not a risk for collision, or harm to people or the environment. For the proposed well, upon conclusion of drilling operations, an as-constructed gyro survey will be submitted to COGCC with the Form 5.


