Hi Kris,

I am submitting the attached completion of the Form 27 Work Plan for Soil Remediation on Remediation Project #7539 for Ephphatha, LLC (Operator No. 10282).

Please note the following corrections that we discussed on ID 2148037 from COGCC to Ephphatha:

1. There was no deviation in testing of samples since the boring at the prosed P-7 was eliminated because of underground water lines. The revised location for P-7 was moved to the proposed P-8 location (location of original hand auger by COGCC).

2. GRO's were sampled with the full Table 910-1 constituents at location P-1, P-2, and P-7, as we discussed on the phone when you verified.
3. The sampling was revised in the field because only 3 borings (P-1, P-2, and P-7) were found to have contamination during screening and a rush was put for analysis on those samples. The constituent list was reduced for the remaining 23 samples that were virtually clean.

Thank you for your consideration and we are awaiting your approval to proceed.
