Attached documentation consists of a letter provided by Nick Marx, Fire Chief of DeBeque Protection Fire District (DFPD), addressing the potential Pond 13 E/W Centralized E&P Waste Facility and it's deviance from COGCC Rule 908.b.(5)D.

Oxy has familiarized the DFPD with the location, terrain, and any access issues that may be associated with the facility. While the Facility does not provide the full ten (10) feet of fire lane and ten (10) feet of buffer zone, Nick Marx is confident that all areas of the Facility will be accessible by the DFPD vehicles and or hoses during an emergency.
