On August 16, 2013 I sent you an email regarding the inspection # 671000003 (Maralex Roan Creek Evaporation Pond/Pit). There were several action items with their respective deadlines. One was the manifest required to close remediation project # 5681 (I received the manifest and closed the project. Thanks!). There was a deadline (Sept 16, 2013) for pulling the weeds around the pit. As of yesterday (Sept 26, 2013) the weeds had not been removed. More important was the Form 27 pit closure work plan which deadline was also Sept 16, 2013, and has not been submitted as of today. So again, this is a friendly reminder that Maralex is not meeting the deadlines. I encourage you to submit the Form 27 work plan, so that environmental investigation can be conducted before winter.
