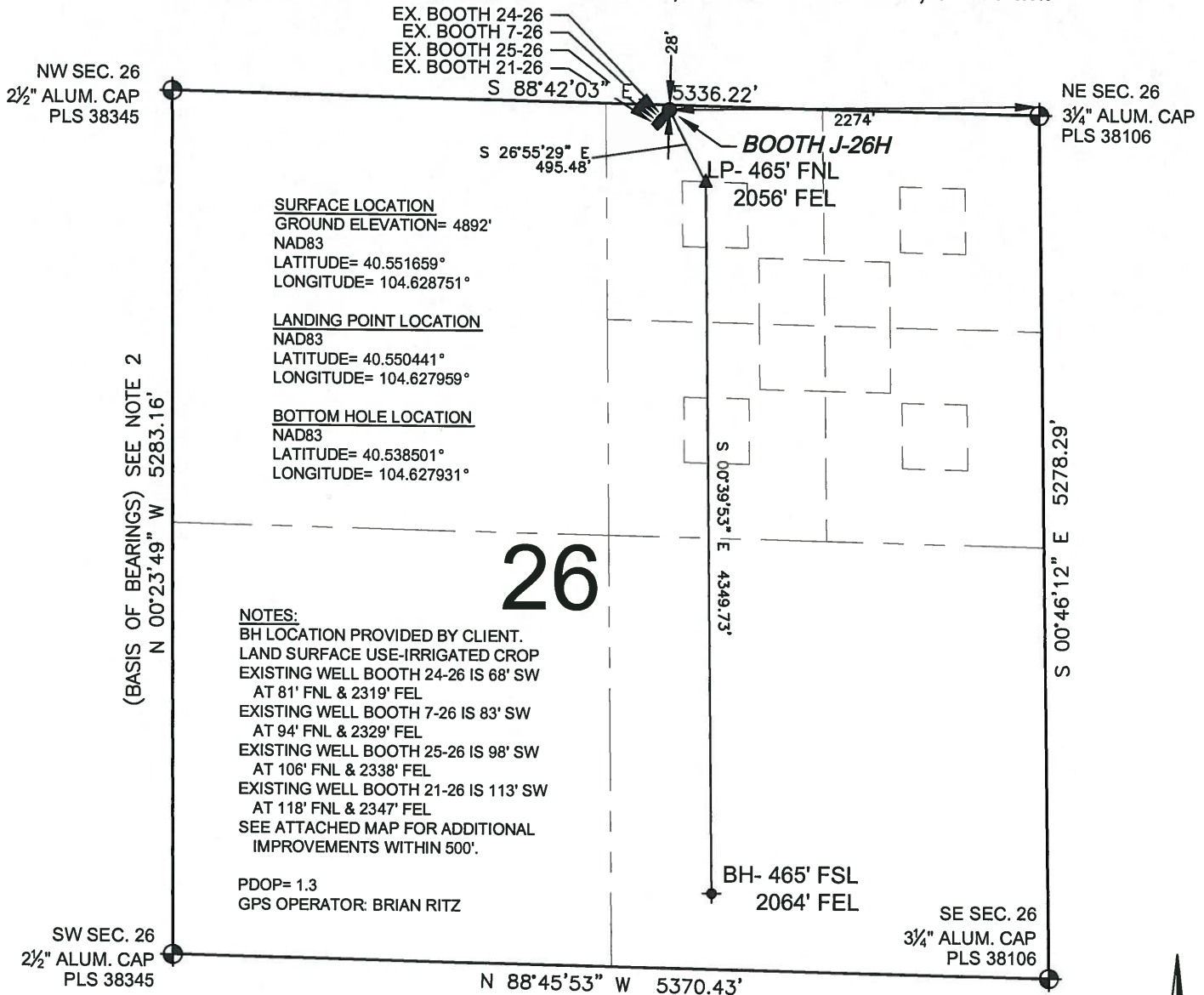
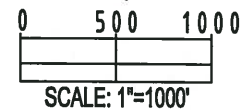


WELL LOCATION CERTIFICATE: BOOTH J-26H

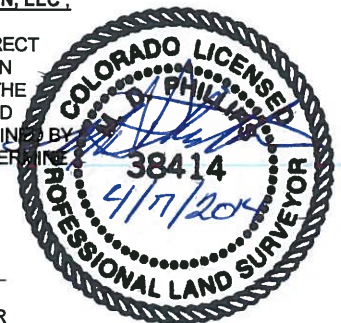
