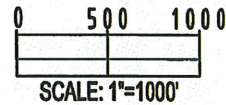

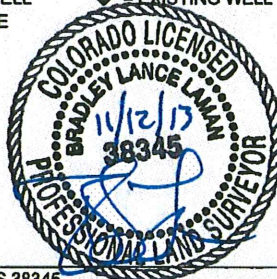
WELL LOCATION CERTIFICATE: SACK 1C-30HZ

SECTION 30, TOWNSHIP 1 NORTH, RANGE 67 WEST, 6TH P.M.

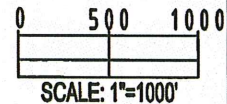
