#### COMMENTS:

Whiting would like to collect geologic data in the form of open hole logs and sidewall core samples in this vertical well prior to its required mitigation due to the DJ Basin Horizontal Offset Well Policy. After drill/clean out of the wellbore we intend to run a triple combo log. After that is complete, we intend to run in with a rotary sidewall core tool and collect samples in the following 10 depth intervals: 6642-6636, 6467-6461, 6435-6429, 6215-6211, 6140-6135, 6030-6023, 5981-5976, 5907-5902, 5832-5826, 5745-5737. Following the collect of logs and core samples we will continue with the mitigation of the well (submitted a Form 6 - Intent to Abandon on 04/08/14).
