Kinder Morgan CO2 CO, L.P. has revised the driveway access for the CNE-4 CO2 well. Kinder Morgan originally planned to access the well from the County Road 9, off of Brad White's property. The well will now be accessed from the west, off of County Road 8. The proposed access will travel through John Kuenzler's property and James & John Wright's property. This new easement will share a driveway access with the proposed CC Cluster (Form 2A in draft). Kinder Morgan has made this change in an attempt to both increase efficiency and minimize unnecessary disturbance. This new access route will also avoid residences along County Road 9 that would have originally been affected by the approved County Road 9 driveway access.

All landowners have consented to the revised easement. Please see attachments for details.
