COMMENTS:

The purpose of this Form 4 is to submit the disposal documents from the berm disposal from the Grant Brothers Gravel Pit. The berms at this location were installed to capture water from the hillside seeps to prevent fluids from entering the ponds located to the northwest on the Grant Brothers Gravel Pit property.

One November 22, 2013 a waste profile was submitted to ECDC Disposal Facility in East Carbon, Utah. The waste profile was approved by ECDC on December 12, 2013. The approved waste profile and associated analytical results are included as an attachment to this submittal. Due to winter weather conditions, the disposal was placed on hold until February 17, 2014 when conditions were warmer. On February 17, 2014 Elder Trucking transported three belly dump truck loads of the remaining berm material to ECDC. A total of 45 cubic yards (15 yards/load) of berm material was disposed. The waste manifest and truck tickets are also included as an attachment to this submittal.

Antero, through its contractor, is confident all impacted soils was removed during this berm removal process.
