COMMENTS:

During bradenhead test procedures the above well has been determined to present conditions needing further review and possible action. Please allow Kerr-McGee Oil & Gas Onshore LP to vent bradenhead valve on the subject well to an enclosed tank for 30-60 days in order to test and determine if further remediation to the wellbore will be necessary. The bradenhead will be vented for 30 days, then shut-in for 7 days and a new Bradenhead test performed. This procedure may be repeated up to three cycles. At the conclusion of the cycles, if the pressure has not satisfactorily decreased a remediation plan will be proposed.
