Erin,

Has the City of Greeley required any noise and/or visual mitigation requirements for Mineral Resources' Triple Creek location as part of the USR process? I'm also curious if the homeowner that is located where the Access Road comes off of 71st Avenue is aware that there will be an increase in oilfield traffic going right by his home soon?

Also due to the proximity of Sheep Draw to this oil and gas location, I'd like to add the following Condition of Approval:

"Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect Sheep Draw located approximately 800 feet northwest of the oil and gas location from a release of drilling, completion, produced fluids, and chemical products."

Mineral Resources had a pre-application meeting with the City of Greeley on January 30, 2014. At that meeting, city staff asked that our first submittal to the city be a Scoping Submittal, which is a "pre" submittal to allow the city to generate comments. That submittal was made to the city on February 7, 2014. We do not have the comments from the city at this point.

Mineral Resources accepts the COA.

At this point, Mineral Resources has not meet with the neighbors.

I do have another question for you. In light of the new MLVT policies, Mineral Resources intends to use up to 3 MLVTs on the property. How should we indicate this on the Form 2A? Do you want me to submit a new location drawing showing the proposed locations.
