The addition of the equipment is to reduce possible flash vapors to abide by the air permitting rules as well as safety. Documentation submitted on 5/1/13 is still viable except the location pictures since the facility has been constructed. The location in rangeland, NRCS Map 22: Cushman fine sandy loam, 6-9% slope, NRCS Map 32: Kim-Mitchell complex, 6-9% slope, NRCS Map 44: Olney fine sandy loam, 0-6% slope. An updated equipment inventory is attached.
