William Ruh and Margorie Ruh, owner of the Subject Lands, for adequate consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby waive the provisions of Rule 318.A. (a) of the Colorado Oil and Gas Conservation Commission's Rules and Regulations that provides that wells shall be drilled within a square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section ("400' Window"). William Ruh and Margorie Ruh hereby consents and authorizes Bill Barrett Corporation to drill, complete and operate the following wells:

RUH 6-62-11-NENW-A being 250 feet FNL and 1920 feet FWL of Section 11, Township 6 North, Range 62 West, 6th P.M., Weld County, Colorado, which surface location is approximately 210 feet outside of the 400' Window of Subject Lands.

RUH 6-62-11-NENW-B being 250 feet FNL and 1935 feet FWL of Section 11, Township 6 North, Range 62 West, 6th P.M., Weld County, Colorado, which surface location is approximately 210 feet outside of the 400' Window of Subject Lands.

RUH 6-62-11-NENW-C being 250 feet FNL and 1950 feet FWL of Section 11, Township 6 North, Range 62 West, 6th P.M., Weld County, Colorado, which surface location is approximately 210 feet outside of the 400' Window of Subject Lands.

RUH 6-62-11-NENW-D being 250 feet FNL and 1965 feet FWL of Section 11, Township 6 North, Range 62 West, 6th P.M., Weld County, Colorado, which surface location is approximately 210 feet outside of the 400' Window of Subject Lands.

By signing this letter you hereby grant your consent to Bill Barrett Corporation to locate the wells outside of a GWA window as defined by COGCC Rule 318A. (a). Additionally, the wells are

being proposed at a surface location which is approximately 4,560 feet from an existing surface well location. By signing this letter you also grant your consent to Bill Barrett Corporation to locate the wells more than 50 feet from the existing wells as provided for under COGCC Rule 318A.(c).
