Attached with this COGCC Form 4 are the laboratory analytical reports for cuttings transported from the RWF 23-32 (COGCC facility #334748) to the land adjacent to the RWF 342-33 well pad (COGCC facility # 311599) as described and permitted with a Sundry Notice Form 4 (document # 400463486).
Approximately 6,000 - 7,200 cubic yards of pit material was excavated from the pit area and transported to the land adjacent to the RWF 342-33 well pad where the material was managed and treated on surface in four separate 1500 to 1800-cubic-yard piles, identified as pile 1, 2, 3, and 4.
One composite sample was collected from each pile and analyzed for the constituents listed in the COGCC Table 910-1. 5 background samples were collected near the RWF 342-33 pad location to establish cleanup concentrations for arsenic. Initially, pile number 2 exceeded cleanup concentrations for barium and piles number 3 and 4 exceeded cleanup thresholds for benzene. These three piles were amended with clean cut slope material and resampled. Subsequent lab analysis was conducted for the constituents that exceeded on initial analysis.
At this time, all constituents are below the COGCC Table 910-1 and the footnote 1 to the Table 910-1 with exception of the inorganics. Therefore, in accordance with COGCC guideline Q32 regarding inorganics, the area adjacent to the RWF 342-33 well pad will be covered with 3' of clean soil during final reclamation of the site in order to account for this exceedance.
