 Attached are the laboratory analytical reports and the sample location map for the produced water release which occurred at the WPX Reda Tank Farm facility on October 18, 2013. A soil sample from the impacted area and three background samples were collected on October 18, 2013. Analytical results from the impacted area are all in compliance with Table 910-1 criteria with the exception of the following:
 Benzo[a]pyrene; 93µg/L COGCC Table 910-1 standard 22 µg/L
 Dibenzo[a,h]anthracene; 49 µg/L COGCC Table 910-1 standard 22 µg/L
 SAR; 19 COGCC Table 910-1 standard 12
 The impacted area was re-sampled on November 8, 2013 and analyzed for Benzo[a]pyrene and Dibenzo[a,h]anthracene. The results were non-detect. It is anticipated the SAR results will naturally attenuate, through natural precipitation events, to levels below 12. With the impacted area now in compliance with Table 910-1 standards for hydrocarbons WPX respectfully requests closure of this incident.
