**COMMENTS:**

Encana respectfully requests a variance from COGCC Rule 902.e., stating a pit may be used for a period of no more than three years. This variance is requested for the SG L27 496 produced water pit located in Encana's Big Jimmy Unit area of operation. (Location ID: 335939 | Facility ID: 414443). The Form 15 was approved on August 29, 2011 (Document #1630805). The one year extension to August 29, 2015 will allow Encana to utilize this pit to support completion operations in the Big Jimmy Unit. Once the Divide Road Water Facility is operational (the Form 28 is currently being reviewed at the COGCC), the SG L27 pit will no longer be needed. The pit will then be closed and the area reclaimed. Encana does not intend for this pit to be converted to an E&P Waste Management Facility.

The L27 pit was constructed with two liners and an interstitial (leak detection) monitoring system which is checked by Operations Personnel on a quarterly basis. Monitoring data and documentation of any required repairs would be kept on file at Encana's Parachute Field Office and is available upon request.
