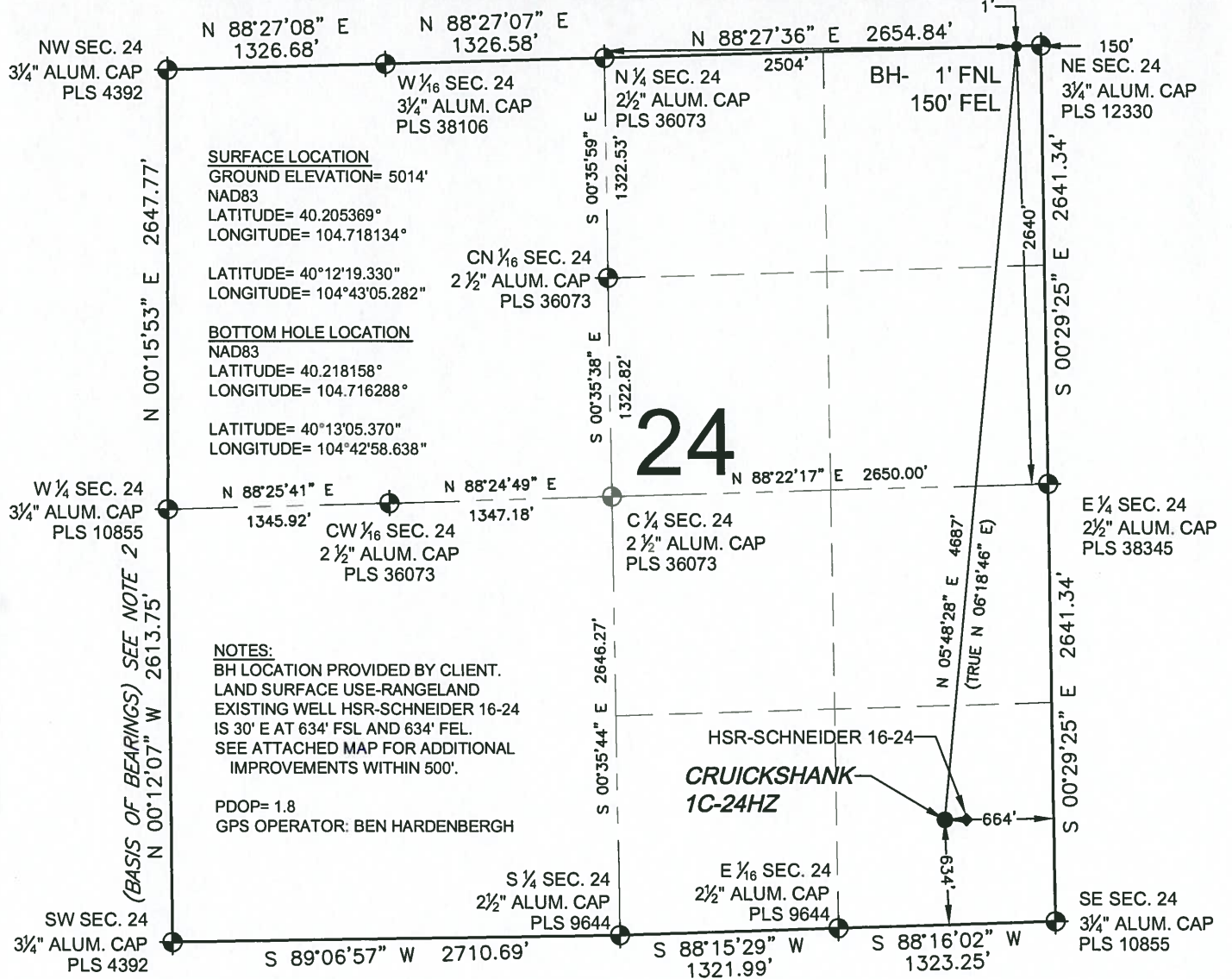


WELL LOCATION CERTIFICATE: CRUICKSHANK 1C-24HZ
