Braidendhead on well is reaching 150 psig. Piceance Energy is requesting permission to run a temporary 2" line to the Combustor on location to allow for bleeding off the braidendhead. Piceance will then monitor the pressure to determine if this is a temporary increase or constant. Once evaluated, Piceance will work up a permanent plan if needed and contact COGCC. The intent is to monitor the braidendhead for a month. The temporary line will be buried or "shaded" with a foot of cover to allow for vehicular traffic.
