## COMMENTS:

Soils within 3 ft of the surface at the release area exceeded COGCC Table 910-1 standards for EC, pH and SAR. Continued monitoring did not show a reduction in levels. On 12/17/13 impacted soils were removed from the release area to 3 ft below ground surface and will be reused as berm material on the adjacent Battlement Mesa 35O pad. Following excavation activities, the site was re-contoured to existng grade. The site remains an active pipeline right of way utilized by Noble and Encana. Noble requests a No Further Action designation for NOAV number 200369316.
