The Colorado St #1 was re-entered and re-plugged with work being completed 3/25/2014. The wellbore was cleaned out and two plugs were set. The surface plug adequately protects the deepest aquifer within 1 mile of this wellbore. This well was originally a DA well with no production casing ever ran, so no pipe was pulled from this wellbore.
